- Parties agree that _____ will be appointed as the Private Child Custody Recommending Counselor.
- The Private Child Custody Recommending Counselor may have access to pertinent information, such as: (1) Child Protective Services history; and/or (2) prior Placer Family Court Services CCRC reports, and (3) prior private CCRC reports regarding the above-named child(ren) and shall keep such information confidential as required by law.
- The Private Child Custody Recommending Counselor may confer with any court-appointed private and/or Family Court Services Child Custody Recommending Counselors, and any court-appointed custody evaluator involved in the case.
- The CCRC session and resulting report will be performed in accordance with the laws of the State of

California, including but not limited to California Rules of Court 5.210, 5.215, California Family Code sections 3177, 3178(a), 3180, 3181(a), 3182, 3183, 3184, and 3185(a) which may be found at www.leginfo.ca.gov/calaw and the Placer County local rules which may be found at www.placer.courts.ca.gov.

9. The Private Child Custody Recommending Counselor is authorized to have ex parte communication with counsel for the minor(s) before a recommendation is made pursuant to Family Code only if the parties stipulate or upon the order of the court.
