



Placer County Superior Court Family Law and Family Support Telephonic Hearing Types

People who have family law cases are permitted to attend some court appearances by telephone instead of being in court personally. If you would like to appear by telephone for your case please check the chart below to see if telephone appearances are allowed for the type of hearing that is scheduled. For some hearing types a judicial officer’s approval is required.

- ***If no judicial approval is required you may sign up directly for the telephone system.***
- If judicial approval is required for a telephone appearance, a party must file Placer County Superior Court Local Form No. PL-FL016 in a Family Law matter and Judicial Council form number FL-679 in a Family Support matter to request to attend a court hearing by telephone.
- After the party files the form the court will notify the requesting party if the request is denied.
- The party may proceed to sign up for the telephone appearance until the party hears from the court.
- If the request is denied, the party making the request to appear by telephone will need to cancel the appointment online and appear in person if they wish to participate in the hearing.

Telephone appearances are authorized as follows. *(As to those hearings that a telephone appearance is not allowed, the judicial officer always has the discretion to allow a telephone appearance upon request by a party based on the individual requester’s situation and the information presented.)*

**The court may give conditional approval to appear telephonically for a probation review hearing if the person is in compliance with their terms of probation. The court may decline to allow the person to participate by phone and instead require personal appearance if he or she has not been granted conditional approval or has, but is not in compliance with their terms of probation.*
