TEMPORARY STANDING ORDER RE
CERTAIN MISDEMEANOR
WARRANTS

EFFECTIVE APRIL 30, 2020,
THROUGH MAY 15, 2020

In light of (1) declarations of a state of emergency by federal, state, and local governments due to the COVID-19 / novel coronavirus global pandemic; (2) Executive Orders by the Governor of the State of California; (3) orders and directives of the Chief Justice of the State of California; (4) the need for the Placer County Sheriff to maintain a jail inmate population in a responsible, reasonable, and safe manner to comply with government public health directives; and (5) discussions with the offices of the Placer County Sheriff, District Attorney, Public Defenders and Probation Department, the court issues the following temporary standing order, effective April 30, 2020, through May 15, 2020:

Law enforcement agencies within this state who have arrested persons on misdemeanor arrest and bench warrants issued by this court

1 may, as qualified below, release the arrestees on a promise to appear
2 directing the arrestee's appearance in the appropriate department of the
3 Placer County Superior Court, at a specific time and on a specific date,
4 approximately 60 days from the date of the arrestee's execution of the
5 promise to appear.

6 A release upon promise to appear described in the foregoing
7 paragraph may be made irrespective of the bail amount of the warrant.

8 An arrestee shall not be released upon a promise to appear in the
9 manner described above if the charge(s) giving rise to the warrant,
10 whether pre-trial or post-trial/judgment are charges for:


- 11 • Domestic violence;
- 12 • Elder abuse;
- 13 • Sexual abuse or charges related to sexual abuse;
- 14 • Charges involving violence or violent conduct; or
- 15 • Driving under the influence.

16 In such circumstances, the arrestee shall not be released except under the
17 bail/conditions prescribed in the applicable warrant(s).

18 Additionally, an arrestee shall not be released upon a promise to a
19 appear in the manner described above where (1) upon review of the
20 criminal history of the arrestee, by either the law enforcement agency
21 arresting the person or by the Placer County Sheriff's Office, it is
22 determined the arrestee should be detained consistent with existing
23 criminal history review practices and policies; or (2) circumstances at the
24 time of the arrest establish that release of the arrestee presents an
25 immediate public safety danger to the community.

26 IT IS SO ORDERED.
