Parties must complete and submit Local Form PL-FL009 to stipulate (agree) to the dates below. *Faxed signatures are accepted and there is no filing fee to submit and file Form PL-FL009.* If your case ends with an odd number please select your dates from the list of "Odd Numbered Cases." If your case ends with an even number please select your dates from the list of "Even Numbered Cases."

The parties may not use the stipulation process for matters under the Domestic Violence Restraining Order (D.V.R.O.) Act and contempt matters and instead shall attend the Trial Assignment ("T.A.") hearing. Respondents in D.V.R.O. matters shall attend the TA hearing and their appearances shall not be waived if represented by Counsel. *For rules regarding remote appearances, please see the court's website regarding remote appearances.*

In the absence of an agreement or if the matter involves a request for a D.V.R.O., a Contempt proceeding or if either party is requesting an expedited or priority hearing (priority hearings include, but are not limited to, DVRO, Contempt or Child Custody) then you will be required to attend the trial assignment hearing to allow the court an opportunity to consider scheduling a date for your trial or evidentiary hearing. The court may have trial and evidentiary hearing dates prior to those listed below available for D.V.R.O., priority and expedited matters at the time of the trial assignment hearing.

Please Note: Family Law matters are civil matters. The Trial (or long-cause Evidentiary Hearing) date provided below is identified as the first day of the trial week. **The day your trial or long cause evidentiary hearing may commence on any day of the designated trial week, including a Friday, as selected by the court at the Trial Confirming Conference "TCC."** Matters may also be placed in trailing status to make optimal use of court resources. At the T.A. hearing a Trial or long cause Evidentiary Hearing may be set for a date certain and as to those cases the court will confirm the date certain at the TCC subject to revision based on courtroom availability and court resources.

All parties shall attend a Mandatory Settlement Conference "MSC" on the date selected or assigned below. Domestic Violence and Contempt matters do not require a mandatory settlement conference.

At a "TCC" hearing the parties may jointly request a continuance of hearing dates, however, in the absence of an agreement a motion to continue must be properly filed with notice for consideration on a family law, law and motion (request for order) calendar.

Please note: Family Code § 2105 requires the final declarations of disclosure to be filed no later than 45 days before the first assigned trial date for matters schedules for final adjudication.
