It is further stipulated that any assigned Commissioner/Juvenile Referee appointed as set forth above shall be vested with the authority to hear any future or further hearings in this matter, including but not limited to all uncontested and contested proceedings, trial and all ancillary proceedings, as a Judge Pro Tempore.
